8AM-12:00PM Controlled Substance Prescribing: Common Pitfalls | Dr. Greg Ayers, Dr. William Suggs

Objectives

1. Describe the pharmacologic profiles of benzodiazepines, opiates and other controlled drugs including the risks involved
2. Identify the diagnostic criteria for substance abuse, anxiety disorder, acute and chronic pain, insomnia, obesity, depression and situations where the continued prescribing of controlled substances would be inappropriate.
3. Employ interviewing techniques relating to the diagnosis and management of substance abuse in general and prescription drug abusers in particular.
4. Discuss case management strategies for the above diagnoses and in special situations such as the elderly, hospice patients and renal insufficiency.
5. Discuss beliefs, stereotypes and attitudes about controlled substance prescribing, controlled drug abusers and chemical dependency, and consider the therapeutic implications of treatment based upon these beliefs.
6. Describe appropriate patient assessment for treatment with ER/LA therapy, as well as possible misuse.
7. Apply proper methods to initiate therapy, modify doses and discontinue use of ER/LA opioid analgesics, applying best practices including accurate dosing and conversion techniques, as well as appropriate discontinuation strategies
8. Demonstrate accurate knowledge about how to manage ongoing therapy with ER/LA opioid analgesics and properly use evidence-based tools while assessing for adverse effects.
9. Employ methods to counsel patients and caregivers about the safe use of ER/LA opioid analgesics, including proper storage and disposal.
10. Review/assess general and product-specific drug information concerning ER/LA opioid analgesics and identifying potential adverse effects of ER/LA opioids.
